APPROVAL OF JUNE 8, 1999 MINUTES

Motion by Chairperson Bullermann to approve the June 8, 1999 Minutes. Seconded by Commissioner Bubolz and carried unanimously.

GENERAL DISCUSSION ON NEW POSITIONS, CHANGES, ETC. FROM THE DIRECTOR OF HUMAN RESOURCES

Director of Human Resources Tami Potkay informed the Commission of two open positions - Associate Planner and Associate Planner/Mapping Coordinator, and will be making an offer to a candidate for Associate Planner/Mapping Coordinator.

City Clerk Bowers requested a change to Chapter 4 with regards to retirees being able to pay for medical benefits under the city policy, like the Police.

## **REVIEW FINAL DRAFT OF CHAPTER 4**

The Commission worked on revisions for Chapter 4, completing the review of all previous changes, and will work on Section 4, Purpose at the next meeting.

#### **ELECTION OF OFFICERS**

Motion by Commissioner Bullermann to nominate Bernie Kramer as Chairman of the Civil Service Commission. Seconded by Commissioner Bubolz and carried unanimously.

Motion by Commissioner Kramer to nominate Jocelyn Bubolz as temporary Secretary of the Civil Service Commission. Seconded by Commissioner Bullermann and carried unanimously.

Motion by Commissioner Bullermann to elect Bernie Kramer as Chairman. Seconded by Commissioner Bubolz and carried unanimously.

Motion by Commissioner Kramer to elect Jocelyn Bubolz as temporary Secretary. Seconded by Commissioner Bullermann and carried unanimously.

These designations will take effect September 1, 1999.

Motion by Commissioner Kramer to move into Closed Session at 9:28 a.m. Seconded by Commissioner Bubolz. Upon voting, Chairperson Bullermann voted "yes", Commissioner Kramer voted "yes", and Commissioner Bubolz voted "yes".
